## **November 9<sup>th</sup>, 2021- 7:00pm- Ogden Twp Regular Board Meeting- Approved Minutes**

### **CALL TO ORDER/PLEDGE TO THE FLAG/ROLL CALL**

- Cemetery Ordinance

  - Clerk Vandebusch will publish information on the Cemetery Ordinance in in the Advance, however there is no legal requirement to do so per Foster Swift.
- Cemetery Survey

- Generator Grant
  - The Grant has been submitted by Clerk Vandebusch on behalf of the Township.

Dennison supported. There is visible dumping of yard waste on the shoulder which may start to cause some road/shoulder erosion issues.
- Election source Invoice
  - Marks motioned to pay Election Source invoice # 21-21343 for Annual Maintenance on Voting machines. Total cost \$3,075.00. Dennison supports. **Roll call vote:** Dennison-Yes, M. Vandenbusche-Yes, A. Vandenbusche-Yes, Van Camp-Yes, Marks-yes. Motion carried.

- Election Source invoice covers required maintenance contract, years 6-10. Coverage starts January 2022 and ends December of 2026.

- One individual spoke during Public Comment. Concern over road condition on curve on Crockett Hwy was noted.
