CALL TO ORDER/PLEDGE TO THE FLAG/ROLL CALL

- Supervisor Marks called the meeting to order at 7:00pm. All stood for pledge to flag. Board members in attendance included: Trustee Van Camp, Trustee Vandenbusche, Treasurer Dennison, Clerk Vandenbusche and Supervisor Marks. No board members absent.

ADOPT AGENDA

- M. Vandenbusche motioned to adopt agenda as presented. Van Camp supported. Motion carried.

APPROVE MINUTES FROM APRIL 13th, 2021 REGULAR MEETING

- Dennison motioned to approve the April 13th, 2021 Regular meeting minutes as presented. M. Vandenbusche supported. Motion carried.

FIRE DEPARTMENT REPORT

- Madison fire department reported out no calls for Ogden during the month of April, 2021.

PAYING OF BILLS

- Dennison motioned to pay all bills as presented. Van Camp Supported. Motion carried.

TREASURER'S REPORT

- Van Camp motioned to accept Treasurers report as presented. A. Vandenbusche supported. Motion carried.

UNFINISHED/OLD BUSINESS

- **Roads-** All joint projects were approved by the other participating township associated with each project.
- **TWP hall survey-** Completed. We approved in another meeting to get property posts. We can now make moves towards getting them installed since we know the exact property lines.
- **Footer-** M. Vandenbusche motioned to pour continuous footer at Ogden Zion Cemetery, totaling \$233 feet. Total cost \$19, 250.00. A. Vandenbusche supported.

- **Website-** Clerk Vandebusch will send out the Website “need/want” list and we can start reaching out to get quotes from companies and make moves towards a working Township website. Pending potential special meeting to discuss with website provider.
- **Election source Invoice-** No Action needed at this time, Per Election sources- our invoice payment isn't due until END of 2021 for Election equipment maintenance for the years 2022-2026.

NEW BUSINESS:

- Insurance Evaluation- M. Vandebusch motioned to Agree to new Appraised values given to use by Decker Insurance after a recent property/asset appraisal. Dennison supported. **Roll call vote:** Van Camp-Yes, M. Vandebusch-Yes, A. Vandebusch-Yes, Dennison-Yes, Marks-Yes. Motion carried.
- Par Plan Grant- Marks motioned to approve Trustee Vandebusch to obtain Quotes for Generators, A. Vandebusch approved. Motion carried. Clerk Vandebusch will submit all required grant information & documentation when the Grant opens on October 1, 2021. The plan is to submit for a match of up to \$5,000.00 for a new generator for the Township Hall.
- Flag Holder- Veteran- Marks motioned to approved a Veteran Flag Holder in the amount of \$56.25. M. Vandebusch supported. **Roll call vote:** Van Camp-Yes, Dennison-Yes, A. Vandebusch-Yes, M. Vandebusch-Yes, Marks-Yes. Motion carried. Flag holder will be purchased on behalf of the township & placed at the Gravesite of A.French- WW2 vet. Flag holder was at request of Family.
- Land Division- Access Requirements There was a question posed around Board Policy around access requirements. Marks motioned to table this until we gain more information from the Assessor. Van Camp supported. Motion carried.

PUBLIC COMMENT

- Two individuals spoke during public comment. Questions arose around Survey/ Property lines and what our intentions were for Township property that's on the north side of the Parking lot.
- Other information was given about recycle center updates, Courthouse remodel updates and Tire Collection Grant at the fairgrounds.
